CONTEST RULES

PRESENTATION

The Centre Cultural El Casino of Manresa, which is dependent on Manresa Town Council, and Taula de les Arts Visuals de la Catalunya Central (TAV-CC) (an association for visual arts in Central Catalonia) call for entries for the fourth edition of the "TAV-CC Contest".

TAV-CC is an independent standing consultative advisory body, whose objective is to promote, disseminate and coordinate visual arts works and contemporary creation proposals, and is made up of associations, facilities and singular projects representatives whose scope is focused on visual and plastic arts within Central Catalonia.

The aim of these Contest Rules is to obtain a grant to develop an artist project which will also carry out an itinerant exhibition through different art centers in the TAV-CC area of influence, Central Catalonia. This itinerary will start with a solo exhibition at Espai 7 of Centre Cultural el Casino.

Selection of artists and projects shall be governed by the following Rules:

MONETARY VALUE OF THE PRIZE

The project development shall have a budget of €2,000, tax included. This amount includes fees and production costs.

Payment periods and method of payment shall be agreed on individually between the artist or artists and the Manresa Town Council.

APPLICANTS

The contest is open to artists either individually or collectively —there are no constraints (age limit, nationality, etc.) — who submit a proposed project in accordance with these Rules.

This call is open to any discipline. Therefore, no artistic disciplines are specified, even though contemporary visual arts proposals will be prioritized.

It is not a prerequisite that applicant artists come from any of the towns and villages in Central Catalonia, although proposals which have something to do with this area of influence shall be valued positively.

DEADLINE AND PRESENTATION

All candidates shall submit their proposals by June 24, 2018, in digital form at the Email: taulaartsvisualscc@gmail.com.

It is a prerequisite to submit all the required documents as indicated.

Organization commits to answer every submission by confirming the correct reception of all documents. If the artist has any issue by delivering the project, he shall be able to contact the organization through the contact details at the end of this rules..

DOCUMENTS TO SUBMIT

The submitted proposals (compressed in a ZIP file) are to include:

1. Data sheet with the basic proposal details (enclosed at the end of this rules), with the following details:

Title of proposal or project

Name and surname (s) of the artist / the collective representative

Email address and phone number of the artist or the collective representative.

Proposal summary (max 10 lines)

Exhibition format summary

Image of the proposal

2. PDF file with the project development or proposal, max 2 MB in size. The title of proposal and the name and surname (s) shall be indicated.

Due to the fact that it is a production grant which includes an exhibition, it is important – specially for investigation proposals or those who have a conceptual / procedural / theoretical character – to include in this document the exhibition format details (if you consider it necessary, you can include sketches and images). It is also necessary to foresee the transportation requirements.

3. Artist(s)'s CV, containing full personal details.

4. High quality image of the proposal or project (300 ppi JPG file)

SELECTION AND VERDICT

The jury will be composed by different profiles linked to visual arts (including theoretical aspects, exhibition and artists), as well as representatives of the different art centers:

Selected artist of an contest's old edition

Curator

Representatives of the different art centers that will show the exhibition

Member of the TAV-CC

Member of the Manresa Town Council

Current artist

Specialist in art theory

The jury's selection will be final and will be publicly announced in June, 28.

PRODUCTION GRANT

The selected projects shall adapt to a calendar and to the exhibition and setting up dates. The artist may carry out their project in their workshop and in the exhibition hall at the setting up times and dates.

The artist(s) shall be in charge of setting up and dismantling, with the support of staff at the different exhibition centers. Transport between the different centers and/or the artist's workshop must be agreed between the artist and the centers, which will facilitate as much as they can.

Setting up dates and transport shall be agreed on individually between the artist or artists and the different exhibition centers.

Centre Cultural el Casino shall be in charge of dissemination, which shall consist of a banner in front of the building of El Casino and a short catalog, TAV-CC and the exhibition centers

EXHIBITION

Exhibition itinerary will start at Espai 7 of Centre Cultural El Casino from September 14 to September 30, 2018. Before the ending of September, 2019, exhibition shall we shown in different exhibition centers of Central Catalonia:

PROPERTY AND DISSEMINATION OF WORKS

The selected works shall belong to the authors, who shall be able to have them at their disposal in order to exhibit and reproduce them, provided that these artists mention that the works have been backed by TAV-CC and Manresa Town Council, along with their corporate logos.

CONDITIONS AND RESPONSIBILITY

The organizers shall take care of the preservation of all received material. Nevertheless, they take no responsibility for incidental damages.

Each exhibition center will be responsible of the received material only during the setting up and exhibition dates.

Participants shall take responsibility for ensuring that their works do not infringe the rights of third parties and shall also guarantee that no image rights can be claimed.

The organizers reserve the right to resolve any issues not established under these Rules that may arise.

ACCEPTANCE OF RULES

Taking part in this call for proposals implies full acceptance of these Rules and the jury's decision, as well as any changes which, as a result of factors beyond the control of the organization, may arise afterwards.
